MANAGER'S REPORT

<u>National Main Street Conference Travel (May 18-20):</u> MSM Zylstra reported that she would like to reserve two rooms for the Main Street Conference for the anticipated four attendees from Wayland. Treasurer Jennifer Antel confirmed that this expense was in our budget.

<u>Design Services for 145 W. Superior Street</u>: MSM Zylstra reported that she has been working with Greg Benett regarding Design Services and Facade Improvements for 145 W. Superior Street. She has given him recommendations for contractors and anticipates the board will see his Façade Grant Application in the next few meetings.

<u>Promotion</u>: Jennifer Antel reported that Main Street Celebration planning is in full swing. She reported that there will be two stages this year and we will be coming up with a solution for shade at the four corners.

Economic Restructuring: MSM Zylstra reported that the ER committee is working with Jessy Lawrence from the Michigan Main Street Center to design our downtown business directory for free. She also reported that the committee is trying to come up with some creative solutions for the building located at 129 S. Main Street. MSM Zylstra stated that although she has shown that building more than any other in downtown, the amount of work that needs to be done is a big deterrent for interested parties.

<u>DDA Master Plan Updates</u>: MSM Zylstra reported that the Public Hearing on April 7, 2014 went well. She stated that there we a handful of property owners that showed up but only one question in regards to signage down by 131. The Master Plan will go to City Council for approval on April 20, 2014.
